DIRECTORY INFORMATION

Each year the District provides public notice to students and their parents of its intent to make available, upon request, certain information known as "directory information". The Board designates as student "directory information": a student's name, parent's name, address, telephone number, photograph-video-or other visual representation, major field of study, participation in officially recognized activities and sports, height and weight, if member of an athletic team, dates of attendance, date of graduation, awards received, honor rolls, scholarships, telephone numbers for inclusion in school or PTO directories, school photographs or videos of students participating in school activities, events or programs. You have the right to opt out of disclosure of directory information for your student. Under the "No Child Left Behind" legislation, military recruiters have access to student addresses from all high school records. If you do not wish to be contacted by a military recruiter, please contact the office to obtain the appropriate form. Male students age eighteen (18) are required to register for the selective service. Parents who do not wish their child's photo or video to be used publicly should contact the school office by September 19, 2016 to sign a form expressing their wish for their child to be excluded from any publication or photo/video. Students who are excluded from the use of photos will not be in the yearbook or in any school publication. The district cannot prevent nondistrict staff from taking photos at events but will not publish any photo or video of a child whose parents wish for them to be excluded and indicate their desire in writing.

NEW STUDENT REGISTRATION

Students new to Pentwater Public Schools should report to the office for registration. Parents of new students must sign a release form for records from the student's previous educational district. Original birth certificates, immunization records and proof of residency are also required. Kindergarten registration—Michigan law states that all children who will have reached the age of five (5) years on or before September 1, 2016, may attend school this fall. Please register your student as soon as possible.

PESTICIDE USE

Parents have the right to request that we notify them 24 hours before applying any fertilizer, weed killer or pesticide in the school. If you would like to receive this notification, please submit your request, in writing, and include the phone number or email address you would like us to use for this notification.

STUDENT ACCIDENT INSURANCE AVAILABLE

Pentwater Public Schools does not provide any type of health or accident insurance for injuries incurred by your child at school. As a service to students/families, we make available a student accident insurance plan at a very nominal cost. You may purchase coverage online at www.1stagency.com and then follow directions by choosing STATE and SCHOOL DISTRICT. Information can be found on our website under Departments/Athletics.

MICHILD

MiChild is a health insurance program. It is for uninsured children of Michigan's working families. MiChild services are provided by many HMOs and other health care plans throughout Michigan. STUDENT RECORDS & PRIVACY

Students 18 years or older and parents of students have the right to inspect and review their education records, request amendments, if inaccurate, or in violation of the student's rights, and consent to disclosure of personally identifiable information other than that allowed by law. Pupil privacy and parental access to information including: certain surveys, analysis and evaluations is protected by school policy. If you have questions about the use of any of the above, please contact an administrator. Parents also have the right to inspect instructional materials other than tests or assessments. School policies comply with the Family Educational Rights and Privacy Act of 1974 and the Protection of Pupil Rights Amendment. FERPA and PPR information can be found in our Student Handbook.

HOMELESS LIAISON

More than 1.35 million children and youth experience homelessness each year. These young people may be living on the streets, but they are most often in shelters or temporarily living with family or friends after losing housing or having financial problems. Homeless children and youth often have problems enrolling and succeeding in school. As a result, Congress passed the McKinney-Vento Homeless Assistance Act in 1987. HEARING AND VISION SCREENING

The local health department is required by law to provide hearing and vision screening to preschool and school aged children. Technicians are in the schools providing this service at certain grade levels throughout your child's school experience. If you do not wish to have your child screened for vision and hearing, please notify the school office.

DRUG PREVENTION

We uphold standards of conduct that prohibit the unlawful possession, use or distribution of illicit drugs and alcohol by students as such use and distribution is clearly wrong and harmful. Disciplinary measures, up to and including expulsion and referral for prosecution will be imposed on students who violate the school standards of conduct. Notification of standards and sanctions is included in the student handbook. Lockers are provided for storage and against incursion by other students, but in no such places shall students have an expectation of privacy as to prevent examination by a school official. Canine detection, conducted in locker areas and in collaboration with law enforcement authorities may be used when appropriate. Guidelines for personal searches are outlined in policy and available for review.

All medications, including nonprescriptions (i.e., aspirin, cough syrup, etc.) must be maintained in the school office with a written directive by the parent for its use. Please call the school office for more info.

In keeping with our goal to offer students a safe and secure environment we can report that procedures for asbestos inspections and handling, pesticide management and warnings, and practice evacuations for emergencies are part of our routines. It is also notable that we had no crimes of physical violence, gang related activity, or illegal possession of substances to report. Our report to the state (SID) on school environment is available for review in the business office. The board of education seeks to protect those staff members who may be exposed to blood pathogens and other potentially infectious materials in their performance of assigned duties. Please refer to policy 8453.01 for further info. The board of education authorizes the use of video surveillance and electronic monitoring equipment at various school sites throughout the district. BUILDING USE POLICY

Please remember the policy regarding the use of the gymnasium and other facilities after school. Students may use the gym and fitness room **only** with adult supervision. Everyone using the gym must sign up during the school day by calling the school office (869-4100 ex. 211). Anyone in the gym who is not signed up will be asked to leave. A form to request use of the gym and other areas is available in the principal office. The fitness room is open to residents and property owners in the district as well as parents of students who attend Pentwater Public Schools. An annual user agreement must be signed and on file. All users of the fitness room **must** be 13 years of age or older. The Board recognizes that good nutrition and regular physical activity affect the health of District students. As required by law, please refer to the board of education's approved policy 8510 as it relates to Wellness for the Pentwater School District.

HANDICAPPED ACCESS

Pursuant to policy 9160, the Board of education welcomes attendance of members of the community at athletic and other public events held by the district. No person with a disability will be denied the benefits of, be excluded from participation in, or otherwise be subjected to discrimination under any program or activity to which Section 504/ADA applies. Upon request to the principal, the District shall make reasonable accommodation for a disabled person to be able to participate in an activity.
